SECTION 4 – FIRST AID MEASURES

- 4.1 Description of first aid measures
- General information: Immediately remove any clothing soiled by the product. Always seek medical help for any exposure.
- After inhalation: In case of unconsciousness place patient stably in side position for transportation.
Supply fresh air. If required, provide artificial respiration. Keep patient warm.
- After skin contact: Immediately rinse with water. Seek immediate medical advice.
- After eye contact: Remove contact lenses if worn. Rinse eye for several minutes under running water. Seek medical advice.
- After swallowing: Do not induce vomiting; call for medical help immediately. Rinse out mouth and then drink plenty of water.
A person vomiting while on their back should be turned onto their side.

SECTION 5 – FIRE FIGHTING PROCEDURES

- 5.1 Extinguishing media: Carbon dioxide, water fog, chemical foam, dry chemical. Material is non-flammable.
- 5.2 General hazards: Material is corrosive, avoid contact and conditions that result in agitating or foaming the material.
- 5.3 Advice for firefighters: Protective equipment: Wear a self-contained respiratory protective device.
- 5.4 Unusual hazards: Do not allow this product to escape into the surrounding environment.
- 5.5 Fire fighting procedures: Keep containers cool with water spray to prevent container rupture due to steam buildup; floor will become slippery if material is released. Material is alkaline and will irritate the eyes if product or fumes contact the eyes.
- 5.6 Decomposition compounds: Oxides of carbon, chlorine, phosphorus, sodium and nitrogen may be released with sufficient thermal energy.

SECTION 6 – ACCIDENTAL RELEASE MEASURES

- 6.1 Protective equipment and emergency procedures: Wear protective equipment. Keep unprotected persons away. Particular danger of slipping on leaked/spilled product. ensure adequate ventilation, material is very irritating, avoid direct contact.
- 6.2 Environmental precautions: Dilute with plenty of water and do not allow it to enter sewers, surface or ground water.
- 6.3 Methods and materials for containment and clean up: Absorb with liquid-binding material (sand, diatomite, acid binders, universal binders, sawdust). Use neutralizing agent. Clean the affected area carefully, dispose contaminated material as waste according to Section 13.

SECTION 7 – HANDLING AND STORAGE

- 7.1 Precautions for safe handling: Ensure good ventilation / exhaustion at the workplace. Prevent formation of aerosols.
- 7.2 Conditions for safe storage: Do not store together with acids or foodstuffs. Store in cool, dry conditions in well sealed receptacles.
- 7.3 Specific end use(s): No further relevant information available.

- 8.1 Exposure controls: **General protective and hygienic measures:** Keep away from foodstuffs, beverages and feed. Immediately remove all soiled and contaminated clothing. Wash hands before breaks and at the end of work. Avoid direct contact with the eyes and skin.
